Subject: Submission of proposals for release of 2nd instalment of Recurring Central Assistance and additional funds for LPG under Mid Day Meal Scheme - reg.

Sir / Madam,

I am directed to say that ad-hoc release @ 25% of the recurring admissible central assistance was released during April-May, 2014 and the balance 35% from the first instalment has also been released during July-August, 2014 to almost all the States / UTs for ensuring smooth implementation of the Mid Day Meal Scheme during 2014-15.

2. Further, the second quarter of the year 2014-15 is already over. By this time, the State Governments must have utilized the recurring Central Assistance released under ad-hoc and balance of first instalment. The State/UTs may now submit their proposal for the release of second instalment of recurring central assistance along with following information:-

- i) Component wise expenditure statement as per Annexure-I confirming that State Government has utilised 60% from the available recurring central assistance (unspent balance as on 01.04.2014 and the recurring central assistance released during 2014-15 under ad-hoc and balance of first instalment).
- ii) Confirmation that the State has released its minimum mandatory matching share against the recurring Central assistance for cooking cost and honorarium to cook-cum-helpers.

3. The States/UTs are also requested to submit proposal for the reimbursement of additional expenditure incurred by them on the procurement of unsubsidized LPG cylinders due to withdrawal of subsidy. The proforma for submission of such proposal is given at Annexure-II.

4. The above said proposals may be submitted in the prescribed formats to this Ministry **by 27th October, 2014** to enable us to release the funds timely. The soft copy of the above proposals may also be sent by email at gaya.prasad@nic.in and jalam.edu@nic.in.
