**Subject:** Restoration of 26314.53 MTs of food grains to State of Andhra Pradesh under National Programme of Mid-Day Meal in Schools (MDMS) for the 3<sup>rd</sup> Quarter (October to December, 2014) and 4<sup>th</sup> Quarter (January, 2015 to March, 2015) for financial year 2014-15.

The Department of Food & Public Distribution has conveyed their approval for restoring a quantity of 26314.53 MTs of foodgrains (Rice) to Andhra Pradesh by reducing it from the allocation of Telangana for the 3<sup>rd</sup> and 4<sup>th</sup> Quarters (October 2014 to March, 2015) out of the allocation of the food grains made under the scheme for 2014-15.

2. States are required to further allocate the food grains to the districts as per their requirement under the provisions of MDM Guidelines and under intimation to this Department as well as Food Corporation of India (FCI) for supply of food grains accordingly.

3. The revised State-wise allocation of foodgrain (rice) in respect of Andhra Pradesh and Telangana for 3<sup>rd</sup> Quarter (October to December, 2014) and 4<sup>th</sup> Quarter (January, 2015 to March, 2015) for financial year 2014-15 is as under-
