Subject: Allocation of food grains to States & UTs under Pradhan Mantri Poshan Shakti Nirman Scheme (PM POSHAN Scheme) for the 1<sup>st</sup> quarter (April to June, 2024) and 2<sup>nd</sup> quarter (July to September, 2024) of Financial Year 2024-25.

## Sir/Madam,

The Department of Food & Public Distribution (D/o F&PD) has concurred the allocation of **1279278.23 MTs of foodgrains consisting of 214258.68 MTs of wheat and 1065019.55 MTs of fortified rice** vide O.M. No. 4-2/2023-BP-II(e-386331) dated 08.03.2024 (copy enclosed) to States & UTs at National Food Security Act (NFSA) prices i.e. Rs.2.00 per kg of wheat and Rs.3.00 per kg of rice under the PM POSHAN Scheme for the 1<sup>st</sup> quarter (April to June, 2024) and 2<sup>nd</sup> quarter (July to September, 2024) of FY 2024-25. Accordingly, the food grains allocation for States & UTs during 1<sup>st</sup> quarter (April to June, 2024) and 2<sup>nd</sup> quarter (July to September, 2024-25 is enclosed at <u>Annexure-II</u> and <u>Annexure-II</u> respectively.

2. States & UTs are requested to further allocate the food grains to their districts as per their requirement on the basis of approved number of children and working days under intimation to this Department as well as to Food Corporation of India (FCI) for supply of food grains accordingly.

3. After receiving food grains allocation from the States & UTs, the District Administration will send a schedule (periodicity and date/week) of lifting of food grains to the local FCI depot depending upon its requirement, transportation convenience and storage capacity. The validity period for lifting of food grains will be 30 days from the date of issue of Department of Food & Public Distribution OM dated 08.03.2024 and for the subsequent months, the validity period will be as per extant guidelines.

4. District Administration may lift allocated food grains on monthly, bi-monthly or quarterly basis as indicated in its schedule, in accordance with the guidelines issued by Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, Govt. of India vide their letter No. 4-7/2018-BP.II dated 25.04.2019, from the FCI godowns. Districts officers are, therefore, required to be directed to lift the food grains accordingly.

5. Payment of the cost of food grains will be made by District authorities within 20 days of the receipt of bills from FCI as per the guidelines issued by this Department vide letter No. 1-3/2022- Desk(PM POSHAN) dated 21.12.2022. The guidelines for decentralization of payment of cost of food grains to FCI at district level under PM POSHAN Scheme may also be downloaded from the website of this Department. These instructions may be followed strictly by all the States & UTs.

6. Procedure laid down in para 5.5 of the above mentioned guidelines dated 21.12.2022 on decentralization of payment of cost of food grains shall be followed meticulously to ensure that the best quality food grains, which in any case will not be inferior to Fair Average Quality (FAQ), is lifted from the FCI godown. The process followed at the time of receipt of food grains from FCI depots should be repeated at each level till the food grains reach the end user to ensure that only good quality food grains are delivered for consumption by children. Records/samples to ensure quality should be maintained at all levels.

7. As per para 5.3 of PM POSHAN Guidelines, a monthly report on off take, payment and quantity of food grains sent to schools/cooking agency may be furnished in the prescribed format latest by 15<sup>th</sup> of the following month on regular basis.

5. The Department of School Education & Literacy is also requested to furnish consolidated Utilization Certificate (UC) duly signed by the concerned DS/Director for the foodgrains allocated to them under PM POSHAN Scheme for the year 2023-24. They may submit the revised allocation of foodgrains during the first half or second half of the financial year after carrying out actual requirement in accordance with the recommendations of Programme Approval Board of PM-POSHAN Scheme (PAB-PM-POSHAN).

6. The Department of School Education & Literacy, Ministry of Education may ensure that FCI gets full payment in respect of foodgrains released by it to States/UTs under the Scheme & utilization certificates are furnished by the State/UT Governments to it in time. They are also requested to make payment of outstanding amounts to FCI without any delays as FCI bears huge amount of interest on unpaid outstanding amount.
