2. Mid-Day Meal Scheme:

A. At School Level

1. REGULARITY IN SERVING MEAL:

Whether the school is serving hot cooked meal daily? If there was interruption, what was the extent and reasons for the same?

Monitoring Institute Observation:

The MI has visited 42 schools and found that majority of the schools serve hot cooked meals during the working hours of the school. However, sometimes it is disturbed by scarcity of water or water like in Bapuji Vidyamandir High School, no mid day meal for poor attendance and pay day in Malay Sardar Para S. B. School. Miahpara High School reported that they receive cooking cost for 10 months, so they serve meal also for 10 months, i.e. after the summer vacation 2011, no mid day meal will be served for the month of May' 2011.

The MDM scheme is very irregular in TankaTilla J. B. School and Ranjan Roy Smriti J B School.

Monitoring Institute Observation:

- 1. The school receives foodgrains regularly with some delays in almost all the schools. The delays are to a maximum of one/two months.
- 2. Buffer stock of one month's duration is not maintained in most of the schools.
- 3. The quantity of food grains is as per the marked/indicated weight.
- 4. The foodgrains are delivered at the school.
- 5. The qualities of the foodgrains are also good.

4. REGULARITY IN DELIVERING COOKING COST TO SCHOOL LEVEL:

Monitoring Institute Observation:

- 1. Majority of the school authorities do not receive the cooking cost in advance. Generally, the extent of delay is upto a maximum of 3 months due to administrative reasons.
- 2. The feeding system is not disrupted because the school ensures the cooks that the payment will be made once they receive the same.
- 3. Cooking cost is paid both by cash and through banks.

Monitoring Institute Observation:

- 1. The MI did not observe any gender or caste or community discrimination in cooking or serving or seating arrangements.
- 2. All students seat on the available space made for mid day meal and takes the meal in an orderly basis. But, in Miahpara High School and Pukuriamura J B School, there is no seating arrangement.

- Many schools display its weekly menu and adhere to the menu displayed. Menu is not displayed in the Bhabanipur H. S. School, Miahpara High School, Kunjaban High School, Jagnakobra S. B. School, Bamarayan H/S School, Bharat Sardar H/S School, Janmejoynagar R.C. S.B. School, Miahpara High School, Janmejoynagar R.C. S.B. School (Pry. Section), Malay Sardar Para S. B. School, New Mandai Girls H.S. School, Dr. B. R. Ambedkar Vidyabhaban, Ranjan Roy Smriti J B School, TankaTilla J. B. School, Badharghat H/S School, Biplabi Bagha Jatin J B School, Mungiabari H. S. School, Uria Para J. B. School, M. K. Gandhi Sr. B. School, Telarbari High School, Madhupur H/S School, Tuichindraibari H. S. School and Purba Hawaibari S. B. School.

- 1. The quality of the meal is good.

School, Miahpara High School, Miahpara High School, Chanmari High School, New Mandai Girls H.S. School, Mohanpur Class XII School and Kunjaban High School.
- 2. The frequency of the health check up is very low like once/year in M. K. Gandhi Sr. B. School, Badharghat H/S School, Chanmari High School, Malay Sardar Para S. B. School, Miahpara High School, Teliamura H.S. School, Rambabu Para S.B. School, Bhabanipur H. S. School, Dhaliai S.B. School, Kunjaban High School, twice/year in Bejimara High School, Sanmura S.B School, Miahpara High School, New Mandai Girls H.S. School, Khumpui Academy and Choudhury Bari Girl's H. S. School,
- Children are not given any micronutrients in the majority of the schools. Micronutrients are given in Dhaliai S.B. School, Bejimara High School, Uria Para J. B. School, Teliamura H.S. School, M. K. Gandhi Sr. B. School (vaccination), Malay Sardar Para S. B. School (vaccination), Rambabu Para S. B. School (Pry.), Chanmari High School, New Mandai Girls H.S. School, Khumpui Academy,

- 3. In almost all the schools, Rs.1000/- is paid to the cooks cum helpers.

But, in the Purba Hawaibari S. B. School, Mungiabari H. S. School, A.D. Nagar H/S School, Kamalnagar Sr. B. School, Tuichindraibari H. S. School, cooks cum helpers get Rs.900/- per month in cash.

- 4. The remuneration paid to cooks cum helpers is not regular and delay is to the extent of three/four months.
- 5. Cooks cum helpers come from all categories of people depending upon the locality and economic condition.

Monitoring Institute Observation:

The school authorities as well as the community people feels that mid day meal has increased the regularity of the students in the schools and helped to reduce drop-out rate. Few school authorities also reported that there is a positive impact on the health of the student also.
