




INTRODUCTION




MAP OF ORISSA






MAP OF KORAPUT







These three revenue districts are situated in the southern part of Odisha and are economically and educationally most backward and have been identified as special focus districts by MHRD, Govt. of India. The table below shows the demographic position of the districts. These three districts have high concentration of tribal population.

So far the rate of literacy is concerned these districts fall behind the national and state average. Majority of the population of these districts depend on agriculture and forest product.

These districts are most backward districts of the State. The percentage of people below poverty line is more in these districts. Again a major problem of Nuapada district is, large scale migration of people to other states in search of work. For amelioration of poverty, these districts are kept under KBK scheme, a special economic package of Govt. of India. Under this backdrop successful implementation of MDM programme bears a special significance in these districts.

As these three districts have been identified as special focus districts by MHRD, Govt. of India, the MI has conducted indepth study of the implementation of the MDM activities.



Chapter - II METHOD OF THE STUDY

The MI adopted field survey method in collecting relevant information from the schools. To collect information in an objective manner adequate numbers of investigators and officials were trained as per the provision in the MOU / TOR.

The Data catching Format (DCF) or Tool suggested by MHRD was reviewed and customized carefully in the light of the TOR, So that all the relevant information can be collected from the schools (Annexure-I)

Selection of Sample :

The schools visited by the investigators and officials of the MI were selected as per the criteria suggested in the TOR.

The selection of the schools were done on the basis of the latest school report card generated through DISE, HHS data and in consultation with the respective DPOs.

In each district 40 schools have been covered by the MI. The list of sample schools are presented in Annexure-II. The Star (*) marked schools have been personally visited by the Nodal Officer of the MI.

3. Regularity in Delivering Food Grains

The schools have not received food grain regularly since reopening of schools after summer vacation. In case of 8(20%) schools they have received food grain regularly and 32(80%) schools have not received food grain regularly. Most of the schools at present have only rice stock with them. The extent of delay varies from 1 to 2 months. The reasons of delay is administrative in nature. However the quantity of food grain supplied was as per the marked /indicated weight. The food grains is also delivered at the school point. The quality of the rice and dal is good.

4. Regularity in Delivering Cooking Cost

No school in the district is receiving cooking cost in advance. The headmasters opined that for more than 3 months cooking cost are not received. The headmasters were managing the cost from the school contingency or from their own pocket. The cooking cost was paid by cash to schools by Block Official.

5. Social Equity

During school visit the monitoring team did not find any school where MDM is cooked separately or Served separately for any specific category of children. There is no gender or caste or community discrimination in cooking or serving or seating arrangements so far as MDM programme is concerned.

6. Variety of Menu

The schools have not displayed the weekly menu. However the menu of MDM programme is common in all the schools.

7. Quality and Quantity of Meal

In all the schools rice and dal are common food served daily. Again in all schools vegetables like potato, brinjal, pumpkins, soya chunk etc. are also added to dal every day. In all schools of the district eggs are given once in a week, but except the schools of Khariar NAC in other schools eggs are not supplied since reopening of school after summer vacation. All the children are satisfied with the quality and quantity of meal.

8. Supplementary

In no schools of the district health card were maintained for children except KGBVs students. Again micronutrients (Iron Tablets, Folic Acid, Vitamin-A dosage) and de-worming medicine are not given to the school children in the district.

9. Status of Cooks

The meal is cooked and served by the cook and helper. In 24(60%) schools cook and helper are appointed by the school managing committee and in 9(22.5%) schools appointed by SHG. All the schools have engaged adequate number of cooks and helpers. The cook gets a remuneration of

Rs.600/- and the helper gets a remuneration of Rs.400/- per month. The cook and helper are not paid their remuneration regularly. They have not received their remuneration for more than six months. Again all the cooks and helpers were women and they belong to under privileged community like SC, ST, OBC.

10. Infrastructure

In 27(67.5%) schools pucca kitchen shed-cum-store are constructed and used by the schools. Again in case of 2(5%) schools kitchen sheds are constructed but not used by school due to its faulty design. In case of 4(10%) schools kitchen shed are under construction and in case of 4(10%) schools kitchen shed not sanctioned. The schools were (1) Tikrapara Primary Schoolof Komna Block, (2) Salingipada U.G.M.E. School of Komna Block, (3) Taj Urdu P.U.P. School of Khariar NAC and (4) Dumerdihi Primary School of Khariar Road NAC.

In case the pucca kitchen shed not available in the schools, food being cooked in verandah and food grain are stored either in school office room or in SHG office.

11. Safety and Hygiene

In 37(92.5%) schools potable water is available for cooking and drinking purpose. Again in 3(7.5%) schools potable water is not available for cooking and drinking purpose. The schools were (1) Krishna Project U.P. School of Komna Block, (2) Putupada Project U.P. School of Khariar NAC and (3) Gadramunda Project U.P. School of Khariar Block. In all schools adequate utensils are available for cooking food. All the schools use firewood as fuel for cooking MDM.

In all the schools the environment, safety and hygiene are good. All the children wash their hands before and after taking meals. The children partake meals in an orderly manner and conserve water while washing dishes. Again there is no schools where cooking place pose any fire hazard.

12. Community Participation and Awareness

As regards to community participation parents usually supervise MDM. In case of 22(55%) schools the parents and SMC participation is satisfactory, in case of 9(22.5%) schools it is poor and in case of 2(5%) school parents and SMC participation is good. In no school roster is being maintained by community members for supervision of the MDM. The awareness levels of parents and community members about quantity of MDM and nutritional value of MDM are satisfactory. Again the general awareness about the overall implementation of MDM programme is satisfactory in the district. The main source of awareness about the MDM scheme are News paper, Television, School and Teacher.

13. Inspection and Supervision

The extent of Inspection of MDM Progarmme by MDM Officials is concerned, State and District level officers have not inspected MDM programme for the last six month. The Block level Officials have inspected MDM programme occasionally during last month.

14. Impact

The Mid-Day-Meal Progamme has helped for improving enrolment and attendance of children in schools as opined by 43 percent headmasters and teachers. Again 32 percent headmasters and teachers opined that general health of children has increased due to MDM programme.

(B) Any other Issues Relevant to MDM Implementation not Covered above

The Mid-Day-Meal Programme in the district is running with great difficulties. Many schools face difficulties to manage MDM programme due to lack of rice and dal stock with them. Thus urgent steps may be taken by authority to supply rice and dal to all schools, so that without any interruption MDM will be available to all school children in the district.

The supply of eggs to schools under MDM programme is not regular in the district. Except the schools under Khariar NAC, in other schools egg are not supplied since reopening of schools after summer vacation. Many headmasters also complain about the quality of eggs. Thus the authority should look into the matter and take necessary steps.

The students at the time of recess are going to their home to collect plate and trays to take MDM and again after taking MDM they returned the same. Due to this practices among students lot of time were wasted. Again students are bringing with them different sizes and types of plates and trays. Thus to save the time and maintain decency one size of trays may be purchased and supplied to all schools under MDM programme.

The MI during their visit observed that due to rainy days students are facing a lot of problems to take Mid-day-meal in an orderly manner. The verandah where they generally take MDM become wet due to rain. Thus steps may be taken to construct all weather dinning room so that without any disturbances students enjoy their mid-day-meal.

1. Regularity in Serving Meal

All the schools visited by MI serve hot cooked meal except Parabeda Upper Primary School, Jeypur. The new SMC has been formed but MDM account has not been opened and the advance cooking cost has not been deposited. Again in Central Primary School, Jeypore and in Kumbharsahi Upper Primary Schools, Joypore MDM was stopped for last one month due to same problem and MDM was resumed on the day of visit by MI.

3. Regularity in Delivering Food Grains

All the schools receive rice regularly. The other materials like Dal, Vegetables, Oil etc. are purchased by SHG/SMC. So there is no problem in managing MDM. The quantity of food grain supplied was as per the marked weight. The rice is delivered at he school point. All the schools have buffer stock of rice for one additional month. At present the MDM programme is managed by Deptt. of School and Mass Education, Govt. of Orissa instead of Deptt. of Women and Child Welfare, Govt. of Orissa. As observed by MI the quality of rice and other materials are good in all the school visited.

4. Regularity in Delivering Cooking Cost

In the district the operational strategies of MDM is in a transitional stage. The newly formed SMC has to manage the MDM progrmame in collaboration or without collaboration with SHG. The schools are opening new pass books with newly appointed Chairman of SMC and Head master. In most of the schools it has not been operationalised. In some cases in rural areas banks are not co-operating. The SSA authorities have placed Rs.10,000/- to each school in advance. But due to non-entry of this advance schools/SHGs are managing MDM from their own fund. The cooking cost was paid by cash to schools by block officials. But this year it may be done through e-transfer and will be deposited in the pass books of the concerned schools.

5. Social Equity

During school visit the MI did not find any school where MDM is cooked separately for any specific category of children. There is no gender or caste or community discrimination in cooking or serving or seating arrangements so far as MDM programme is concerned.

6. Variety of Menu

All the schools have displayed the weekly menu. The menu of MDM programme is common to all schools and it is decided centrally by the Deptt. of School and Mass Education, Govt. of Orissa. The food served on every days is as follows. Monday-Rice and Dalma, Tues day. Rice and Soyabin curry, Wednesday-Rice and Egg curry, Thursday-Rice and Dalma, Friday-Rice and Egg curry and Saturday-Rice and Dalma.

7. Quality and Quantity of Meal

The quality and quantity of MDM per children has been increased. In all schools visited by MI it was observed that all the children are satisfied with the quality and quantity of meal. Egg is served to children twice a week.

8. Supplementary

In no schools of the district health card were maintained for children. Again micronutrients (iron tablets, folic acid, vitamin-A dosage) and deworming medicine are not given to the children.

9. Status of Cooks

The meal is cooked and served by the cook and helper. In 22 schools they are appointed by SHG and 18 schools they were appointed by SMC. All the schools have engaged adequate number of cooks and helpers. The cook gets a remuneration of Rs.600/- and the helper gets a remuneration of Rs.400/- per month. They get their remuneration

through Bank channels. The cook and helper are not paid their remuneration regularly, for more than 3 months they have not received their remuneration. Again all the cooks and helpers are women and they belong to under privileged community like SC or ST.

10. Infrastructure

In 26(65%) schools pucca kitchen shed cum store have been constructed and are in use in the district. In 2(5%) schools the kitchen are under construction whereas in 2(5%) schools the fund is sanctioned but the construction has not been started. In 10(25%) schools the fund for kitchen is not yet sanctioned. The schools are managing the cooking place from their existing structure with temporary shed or in rejected classroom and food grains are stored in office room or the SHG keep it in their custody. In all schools potable water is available for cooking and drinking purpose. In all schools adequate utensils are available for cooking food. All the schools in the district use firewood as fuel for cooking MDM.

11. Safety and Hygiene

In 35(87.50%) schools the environment is alright from safety and hygiene point of view. All the children wash their hands before and after taking meal. The children partake meals in an orderly manner and conserve water while washing hands. Again in no schools where cooking place pose any fire hazard.

12. Community Participation and Awareness

As regard to community participation parents and SMC members usually supervise the MDM. 80% SMC members supervise MDM regularly and 50% SMC members come to school regularly. But roster is not maintained by the community members in any school for supervision of MDM. The awareness level of parents and community member is satisfactory as regards to entitlement of quantity and types of food materials supplied in MDM. Nutrients are not supplied in the district. The general awareness about the over all implementation MDM programme is satisfactory in the district. The main source of awareness about MDM scheme is villagers, friends, teachers, TV and radio and meetings of SSA. From the discussion it is derived that MDM had improved enrollment and attendance of children in school and 35 (87.50%) Headmasters opined that MDM has improved the general well being and nutritional status of children. It was also observed that on the day eggs are given attendance is more in most of the schools.

13. Inspection and Supervision

The MDM programme is regularly supervised by the SMC, PTA and MTA members and also SSA authorities. Sarpanch , Ward Members and Block Officials also supervise the programme. Now some of them are in the Janch Committee to supervise the MDM programme.

14. Impact

Most of the children in sample schools in the district belong to families from below poverty line and from socially disadvantaged group and they depend on MDM for food. It gives food security to children. Their parents are wage labourers and go to work early in the morning. In such case earlier the children were not in a position to come to school. But at present even it mother is not in house to feed the child, the child is coming to school because of MDM. The headmasters and teachers have positive views towards the implementation of MDM. In the days, eggs are served the attendance of children is significantly high.

(B) Any other Issues Relevant to MDM Implementation not Covered Above

The honorarium of cook and helper should be paid regularly at the end of every month as they belong to poor families. All the children should be supplied with micronutrients periodically and their health status should be monitored regularly. Health Card should be maintained for each and every child with health check up at regular intervals. In many schools visited low cost hostels are there, where 50 to 100 students are staying. In such hostels attention need to be paid towards sanitation skin care of students. Many students were found to have skin diseases. Instead of fire wood LPG gas should be supplied especially to the primary schools of urban areas. Again uniform plates for eating foods should be supplied from school as the children are going to their home to collect plates and wasting time for it. It was observed that eggs are not provided regularly. Steps should be taken to provide eggs regularly.

1. Regularity in Serving Meal

In 36(90%) schools MDM is managed by the local self help groups and in 4(10%) schools MDM is managed by the SMCs. In all sample schools hot cooked meal is being served daily. The MI observed that there is no interruption in this activity.

2. Trends

From the record it was ascertained that there is variation in enrolment of children and no. of children opted for mid-day-meal. It was observed that there is no variation in number of children availing MDM as per MDM register and number of children actually availing MDM on the days of visit. On the previous days also there is no variation in the number of children recorded in the register and number of children availed MDM.

3. Regularity in Delivering Food Grains

All the schools receive rice regularly. These schools have buffer stock of rice for one additional month. The other materials like dal and vegetables are purchased by SMC as per the revised guidelines. The quantity of food grain supplied is as per marked/ indicated weight. The rice is delivered at the school point. The quality of rice and dal in all schools are good as observed by MI.

4. Regularity in Delivering Cooking Cost

Recently the schools in the district have received cooking cost in advance. Only Rs.10,000/- has been deposited in the pass books of each school to meet the expenses in advance. But there are several instances that the SHGs or the headmasters have to manage the cooking cost from their own pocket.

5. Social Equity

During school visit the monitoring team did not find any school where MDM is cooked separately on served separately for any specific category of children. There is no gender or caste or community discrimination in cooking or serving or seating arrangements so far as MDM programme is concerned.

6. Variety of Menu

All the schools have displayed the weekly menu. The menu is prepared centrally by school and Mass Education Department, Govt. of Orisha. The Menu is as follows :

Monday :	Rice and Dalma (dal added with vegetables)
Tuesday :	Rice and Egg curry,
Wednesday:	Rice and Soyabin curry,
Thursday :	Rice and Dalma (dal added with vegetables)
Friday :	Rice and Egg Curry,
Saturday :	Rice and Dalma (dal added with vegetables)

All the schools are following the guidelines as observed by MI.

7. Quality and Quantity of Meal

In all schools observed by MI the quality and quantity of MDM is satisfactory. All the children were found satisfied as observed and interacted by the members of the MI.

8. Supplementary

In no schools of the district health check up and health card are maintained. Again micronutrients (iron tablets, folic acid, vitamin-A dosage) and deworming medicines are not given to any children of any schools.

9. Status of Cooks

The meal is cooked and served by the cook and the helper. In 36(90%) schools the cook and the helper are appointed by SHG and in 4(10%) schools they are appointed by school through SMC. All the schools have engaged adequate number of cooks and helpers. The cook gets a remuneration of Rs.600/- and the helper gets a remuneration of Rs.400/- per month the remuneration is paid through bank channel. The cook and the helper are not paid their remuneration regularly. For last 3 months they have not received their remuneration. All the cooks and helpers are women and they belong to SC/ST or OBC community.

10. Infrastructure

In 29(73%) schools pucca kitchen shed-cum-store have been constructed and are in use in the district. Again in 10(25%) schools kitchen have not been sanctioned and MDM is cooked in temporary arrangement. In one school (2%) the fund for construction of kitchen has been sanctioned but the work has not been started. In all schools drinking water is available for cooking and drinking purpose. In all schools adequate utensils are available for cooking food. All the schools in the district use firewood as fuel for cooking MDM.

11. Safety and Hygience

In all the schools the environment is alright from safety and hygiene point of view. All the children wash their hands before and after taking meal. The children partake meals in an orderly manner and conserve water while washing dishes. Again there is no schools where cooking place pose any fire hazard. However it was observed in few schools, during rainy days due to lack of sitting space, students face difficulties in taking MDM and the programe is not organized properly. So for such schools provision of all weather dinning hall should be made.

12. Community Participation and Awareness

As regards to community participation members of SMC, parents supervise MDM regularly. Seventy percent of SMC and SHG members come to school daily to supervise MDM. No roster is being maintained by the community members in any school for supervision of MDM. The awareness level of parents and community member is satisfactory as regards to quantity and quality of MDM per child as supplied in the menu. Again the general awareness about the over all implementation of MDM programme is satisfactory in the district. The main sources of awareness about the MDM scheme is Television, News Paper, School, Teachers and Community members.

13. Inspection and Supervision

Relating to inspection and supervision of MDM programme as per the new guidelines in every school monitoring committee has been formed with community members, BRC/CRC, , Ward members, and Sarpanch as members. The new guideline has just been implemented in the month of August, 2011. This committee has to supervise the MDM regularly. As viewed by the teachers all are becoming functional in supervising MDM. It was also seen that during last six months the block level officials and the State level officials have not inspected the MDM programme in any school.

14. Impact

As expressed by the headmasters, teachers and community members the MDM programme has immensely helped for improving enrolment and attendance of children in schools. Again 70% headmasters viewed that MDM has increased the general health of the children from under privileged class. It was observed by MI that on the days of supply of eggs the attendance of children is very high. It motivates them to come to school.

(B) Any other Issues Relevant to MDM Implementation not Covered above

It was observed by MI that MDM is not served to the students of class VI & VII in urban areas. All the students should be included under MDM. Instead of fire wood, LPG gas should be provided especially in all urban schools. The cook and helper should be paid their honorarium regularly. The school should procure uniform plates and trays for all children under MDM. Instead of making MDM as a programme of hunger alleviation, it should be viewed as an educational activity where the children learn so many educational values like cleanliness, leadership egalitarian spirit, water conservation etc. Thus teachers should be oriented and should be entrusted to supervise the MDM programme even if SHG/SMC is in charge of MDM. In all teacher training programme it should be highlighted and should be an integral component in teacher training programme. The supply of egg should be regular in the district in order to attract the children to school. The quality of food should be monitored regularly.

Chapter - IV C O N C L U S I O N

The three districts visited by the Monitoring Institute for monitoring and Supervision of MDM programme are tribal dominated districts of the state and have been identified as special focus districts by MHRD, Govt. of India. These districts are also economically and educationally very backward districts of the State.

As Mid-Day Meal programme has become a catalyst for a host of education-related benefits, its coverage, efficacy and monitoring is highly important.

As observed by the MI, attendance and enrolment rates, especially in case of girls, SC, ST and minorities have shown significant increase, learning achievement is found to be higher in schools serving Mid-Day-Meals. Parents in rural areas who go to fields have reported that it has now become easier to send their children to schools. In schools also now it has become possible to retain the children in the schools after the lunch break.

However the MI likes to suggest few lines in this context.

In the three districts visited, in more than 80% of schools MDM is managed by SHGs and school teachers, members of MTA and PTA are supervising the MDM programme. The MI felt the necessity imparting training to such members on the need, importance and management of MDM along with safety, hygiene and cleanliness of the programme and preservation of food grains.

Further in all schools visited same food is served daily i.e. rice and dal/dalma and menu is not displayed in any school. So one additional item (curry) may be added to the menu and menu should be displayed in all the schools.

Excepting very few schools, the students take MDM in plates/ disces of different sizes and shapes and in many cases they go home during recess to bring the plates/ disces which kill time. So provision of plates/ disces should be made in all schools which will be uniform, decent and will save time.

Further provision of LPG gas should be made for schools in urban areas and KGBVs.

In Nuapada district seasonal migration is a common phenomena and this district is a drought pron district. So provision of MDM should be done for the children of this district for the whole year in holidays and vacations also.

In many schools especially in urban areas there is lack of physical facilities and during rainy season, it becomes very difficult for students to take MDM in an orderly manner due to lack of space. So provision of all weather dinning space should be made in such schools.

There is a bright prospect of involving the local corporate sectors or voluntary organisations to take the responsibility of MDM through publicprivate partnership. Steps may be taken in this direction so that MDM can be managed effectively in urban areas.


