Sir / Madam;

I am directed to intimate that Ministry of Consumer Affairs, Food & Public Distribution has agreed to supply the foodgrains on post-payment basis vide letter no. 191(1)/2004-FC.A/cs (Pt.) dated 5th February, 2015 (copy enclosed).

2. The States / UTs are requested to follow the guidelines of this Department issued vide letter no. 1-15/2009-Desk(MDM) dated 10th February, 2010 regarding timely payment of cost of foodgrains to FCI. It is also requested to ensure that the monthly meetings are held regularly by the district authorities with the FCI authorities to sort out the issues relating to delay in making payment and clear the bills within the stipulated time of 20 days.
3. The States / UTs are further requested to ensure that the bills of the foodgrains lifted from FCI Depot are paid to FCI within 20 days after receipt of the bills.
4. The States / UTs are also requested to send the Monthly Progress Report by 5th of every month in the prescribed format to this Ministry on regular basis. The same may also be sent through email at gaya.prasad@nic.in and jalam.edu@nic.in


