- ii. To consider the Annual Work Plan and Budget (AWP&B) 2017-18 proposal of Chhattisgarh for MDM Scheme.

2. Shri G. Vijaya Bhaskar, Director MDM and Member Secretary, welcomed the members of PAB-MDM and other participants. He requested Joint Secretary (EE.I), to make his opening remarks. Joint Secretary (EE.I) appreciated State Government's good practices/initiatives viz. Pre-positioning of one month's funds with implementing agencies; e-transfer of funds to implementing agencies and cook-cum-helpers; engagement of women self help groups for cooking MDM in rural areas; additional contribution of Rs 200/- by State towards honorarium to cook-cum-helpers; opening of bank accounts for all cook-cum-helpers; development of software for on line management and monitoring of food grain, payment of cooking cost and honorarium of cooks- cum- helpers and Toll free number 18002331152 for Grievance Redressal system.

3. Shri Vikas Sheel, Secretary (Education), Govt. of Chhattisgarh made a presentation on the implementation of MDM and the initiatives taken by the State Government for improving the effectiveness of the scheme in Chhattisgarh. Shri Bhupendra Kumar, Senior Consultant, Technical Support Group-Mid Day Meal (TSG-MDM), also presented an analysis of the performance of the State in the implementation of Mid-Day Meal Scheme during the first three quarters of the year 2016-17.

4. The following issues were discussed during the meeting:

4.1 Coverage of children: It was informed that 86% of the enrolled children at primary and 83% at upper primary level have availed MDM on an average basis during 2016-17.

4.2 Kitchen cum store: Director (MDM), Govt. of India mentioned that out of 47266 sanctioned kitchen-cum-stores, State has completed construction of 42636 kitchen-cum-stores and construction is under progress for 4630 Kitchen-cum-stores. JS (EE.1) enquired about the timeline

for completion of construction of these 4630 kitchens. Secretary, Govt. of Chhattisgarh informed that the construction for these 4630 kitchens will be completed by August, 2017.

4.3 Use of LPG: Joint Secretary (EE.I) observed that LPG as fuel is being used in only 4% schools. Secretary, Govt. of Chhattisgarh mentioned that efforts are being made to increase the usage. He further requested for waiver of initial deposit on new LPG connections and for central assistance for procurement of gas chulha and burners. JS (EE-1) assured that the matter may be taken up with the Ministry of Petroleum and Natural Gas. He also clarified that MoPNG has already issued instructions to oil companies to link LPG subsidy to schools with Unified District Information System for Education (U-DISE) by treating them under Non-Domestic Exempt Category for subsidy purpose. Shri Bhupendra Kumar, Sr. Consultant, TSG informed that the State has submitted proposal for replacement of 22420 units of kitchen devices, which were sanctioned during 2012-13. Director (MDM), Govt. of India observed that as per MDM guidelines, gas chulha and burners can be procured from the funds meant for kitchen devices. He further advised these funds may be used for procurement of gas chulha/ burners also.

4.4 Tasting of meal by parents: Joint Secretary (EE.I) observed that Parents / community members taste meals in only 3% schools before it is served to children. He emphasized upon the role of community in ensuring the quality of meals served in schools and advised the State to take necessary action. Secretary, Govt. of Chhattisgarh assured to take necessary action in this regard.

4.5 Data Entry on MIS-Web Portal: Joint Secretary (EE.I) observed mismatch in the data submitted through AWP&B and the data entered in the MDM-MIS especially in respect of utilization of foodgrains and cooking cost. He advised the State officials to develop a mechanism to ensure accuracy and quality of the data entry in MDM-MIS. Secretary, Govt. of Chhattisgarh assured to take necessary action in this regard.

4.6 Automated Monitoring System (AMS): Shri Bhupendra Kumar, Sr. Consultant, TSG informed that State is submitting data for only 20% schools in the Automated Monitoring System. JS (EE.I) advised the State to take necessary steps for submitting information for 100% schools. Secretary, Govt. of Chhattisgarh informed that at present only mobile App is being used in state for daily data collection. He added that the State is in the process of getting the information on daily attendance of Student and teachers through Tablets. He also informed that the training of teachers for this will be conducted by 30th June, 2017.



4.7 Meeting of District level Committee: JS (EE.I) observed that no meeting of District level committee under the chairpersonship of senior most Member of Parliament of Lok Sabha, has taken place in 24 districts. Secretary, Govt. of Chhattisgarh assured to look in to the matter.

5. PAB-MDM approvals for the year 2016-17

It was clarified that the quantification of resources is only an estimate for release of Central Assistance during 2017-18 under the MDM Scheme. The MDM Guidelines provide that every child attending an eligible institution is to be covered under the Scheme and shall be served mid-day meal on all school days. In case the State Govt. finds that the average number of children availing mid-day meal and/or if the working days are more than the approved numbers by PAB-MDM, they may approach the GOI at any time with justification for additional Central Assistance.

After discussions with State officials and based on the performance during first three quarters of 2016-17, the PAB-MDM approved the following number of children, number of school days etc. for quantifying the Central assistance for Chhattisgarh:-

The State is advised to disseminate the approvals of the resources to all the field functionaries in the State and districts so as to enable all the eligible institutions to ensure that every child attending an eligible school must be served hot cooked midday meals on all school days irrespective of the approvals of PAB-MDM.
7. The quantification of central assistance of Rs. **310.19** crore has been done as per existing norms on the basis of number of children and working days as approved by PAB-MDM for the year 2017-18. The Component- wise approval of funds for 2017-18 is enclosed at Appendix-1 If the norms for cooking cost or any other component are revised during 2017-18, the quantification of central assistance would also be revised accordingly.

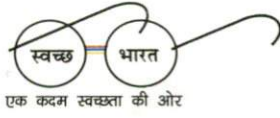
