Subject: Format to capture the school wise Aadhaar Enrolment data through MDM-MIS Web portal -reg.

This Ministry has issued Notifications making Aadhaar Enrolment necessary for the beneficiaries under Mid-Day Meal Scheme (MDMS). In this regard, this Department has issued letters to all the State/UTs-

- i. D.O. letter dated 16th March, 2017 from Secretary (SE&L),
- ii. D.O. letter dated 12th April 2017 from Joint Secretary(EE.1) and
- iii. D.O. letter dated 12th April 2017 from Joint Secretary (EE.1) for 100% Aadhaar Enrolment within stipulated timelines.
- 2. It is essential that every child either have Aadhaar card or must have submitted application for Aadhaar card for Aadhaar Enrolment who desire to avail Mid-day meal. The States/UTs are carrying out drives for Aadhaar Enrolment of children; the progress is being rigorously monitored at different levels.
- 3. In this regard this Ministry has prepared a **format to capture the school wise Aadhaar Enrolment data through MDM-MIS Web portal** (Annexure-I). The data entry shall be done from District/Block level user into the MDM-MIS web portal www.trgmdm.nic.in on a weekly basis (every Friday). A reporting format has also been developed to monitor the progress on Aadhaar enrolment data collection of each District/Block (Annexure-II). It is requested to ensure that District MIS coordinators/Block MIS Coordinators are deputed for the said assignment. You may appreciate that this will also help in identifying the pockets/schools where the gaps are in terms of Aadhaar enrolment.
- 4. Action taken on the issue of furnishing the Aadhaar Enrolment data in the MDM-MIS web portal on weekly basis (every Friday) in a time bound manner, duly validated at your end may please be ensured so that the eligible children are benefited from MDM Scheme.
