Dear Sir/Madam,

Please refer to my D.O. letter of even number dated 30th September, 2022 (copy enclosed) regarding annual and monthly data entry status for financial year 2022-23 on the Management Information System (MIS) web portal. It is appreciated that owing to your efforts, the annual data entry of 8.98 lakh schools out of 10.91 lakh schools has improved with a 10% increase in data uploaded. In particular, the States of Arunachal Pradesh, Bihar, Chhattisgarh and Assam have made over 20% progress in schools' annual data entry from the previous month. Nevertheless, in order to make the MIS robust and effective, all States/UTs need to complete 100% annual data entry without any further delay. The State/UTs-wise annual data entry status is placed at **Annexure-I**.

2. Unfortunately, there is only little improvement in the school's monthly data entry, i.e. only 59% of schools' monthly data entry on an average basis has been completed at the national level. While States of Uttarakhand, Chandigarh and Jharkhand have completed 100% monthly data entries from April to September, 2022, certain States/UTs viz. Haryana, Telangana, Ladakh, Punjab, Maharashtra and Kerala have also shown good progress and completed more than 90% schools' monthly data entry. The UTs of Lakshadweep and Puducherry have not initiated schools' monthly data till date. The State/UTs wise monthly data entry status is placed at **Annexure-II**.

3. I would request for your personal intervention kindly to ensure that adequate mechanisms are put in place for taking effective measures on the above points and

direct the concerned officials of your State to extend their full cooperation in making correct and timely entries into the MIS and AMS portals of PM POSHAN (www.education.pmposhan.gov.in). An early action in this regard would be highly appreciated as it would ensure that the real-time data on the implementation of the PM POSHAN is available to all the decision makers and implementors at various levels.

Let us join hands to ensure that every eligible child gets hot cooked meal on all school days.

Dear Sir/Madam,

As you are aware, the PM POSHAN Management Information System (MIS) has been established by this Ministry for online monitoring of the scheme across the country. This online MIS System helps to monitor PM POSHAN from the Central level to Block levels. The utility of the MIS is predicated on the base line data entered initially. Owing to your efforts, the Annual data entry of 8.00 lakh (73%) schools out of 10.95 lakh schools has been completed. The State/UTs-wise details are placed at Annexure-I. However, in order to leverage full advantage of the MIS, we need to reach 100%, with little more effort.

2. The monthly data entry of the schools into the MIS web portal is also important and continuous activities are to be completed within 10 days after the end of the previous month. The monthly data entry module captures important data against parameters like coverage of children, school working days, consumption of food grains, payment to honorarium to Cook-cum-helpers, children health checkup etc. under PM POSHAN. **Various critical reports are being generated** on the basis of these inputs for monitoring purposes of the scheme. However, national average **monthly data entry status is only 50% as on 27.09.2022**. The efforts made by Uttarakhand (100%), Jharkhand (99.6%), Ladakh (97.8%), Kerala (94.8%) and Punjab (91.6%) are appreciated in this regard. The State/UTs-wise monthly data entry status are placed at Annexure-II. Needless to say, many State/UTs need to put in additional attention to make the monthly data entry up to date.

3. The Automated Monitoring System (AMS) has been developed for real-time monitoring of the scheme in which every school Head Master/Teacher, looking after PM POSHAN in their schools, sends an SMS through their mobile on daily basis. 17 States/UTs out of 36, have adopted the AMS application developed by NIC, Himachal Pradesh while other States/UTs have developed their own application. This AMS application is very useful to monitor the Scheme on a daily real-time basis. The critical and exceptional reports viz. **schools where meals are not served for five days in a month, schools where meals are not served for three days continuously**, etc. are available on the website. These reports help to monitor the

scheme at the State level, District level, and even block level. Just to give an example, the AMS report from 1st September to 26th September, 2022, revealed that in certain areas, only 23 to 47% of the children were being served daily meals on an average basis. As you may appreciate, **such reports would assist in taking immediate corrective action**. The report on the serving of meals in the schools on daily basis is available at the URL (<http://164.100.160.114>). Unfortunately, the level of daily reporting under AMS in many States is very low and a cause of concern. I would request that action to be taken to improve reporting urgently.

4. Further, if you require any technical assistance on the above matter, do contact our technical team, PM POSHAN, Ministry of Education. You are also requested to strengthen the technical team at State/UTs level for constant monitoring and technical facilitation to ensure a robust MIS and AMS system.

5. I shall appreciate if you could kindly ensure that adequate mechanisms are put in place for taking effective measures on the above points and advise the concerned officials of your State to extend their full cooperation in making correct and timely entries into the MIS and AMS portals of PM POSHAN (www.education.pmposhan.gov.in). An early action in this regard would be highly appreciated. Intervention on your part will ensure that the real-time data on the implementation of the PM POSHAN is available to all the decision makers and implementers at various levels.

Let us join hands to ensure that every eligible child gets hot cooked meal on all school days.
