Sir / Madam,

As you are aware that this Department had already launched Web Portal in the month of July, 2012 to monitor the Mid Day Meal Scheme. In this connection it is informed that orientation workshops on MIS web portal with all States / UTs was organized to orient the officials of the State Governments to feed the annual and monthly data into the portal. Till date, annual data for 11.18 lakh schools have been entered by the States / UTs and all the States / UTs are feeding the monthly data into the portal.

Further, it is informed that the progress on annual data entry is quite satisfactory but progress of the monthly data entry into the portal requires your personal attention. The Annual Work Plan & Budget formats have already been circulated to all the States / UTs and a separate table has been included in the format to capture the progress on the data entry into the portal. The Programme Approval Board for Mid Day Meal Scheme would review the progress on annual and monthly data entry upto December, 2012 while approving the Annual Work Plan & Budget for the next year i.e. 2013-14.

I am happy to intimate you that the Fund Flow and Foodgrains Management module of the MDM MIS is now ready for data entry and is available on <a href="https://www.trgmdm.nic.in">www.trgmdm.nic.in</a>. These modules have been shared with all States / UTs through Video Conference (VC) sessions conducted on <a href="https://www.gots.nic.in">31st December, 2012</a> for 18 States / UTs and on <a href="https://www.gots.nic.in">2nd January, 2013</a>. for 17 States / UTs. The same has also been shared with States / UTs through Regional Workshops held during January, 2013 at 4 places viz. Madurai, Udaipur, Gangtok and Bhopal.

In order to facilitate the States/UTs for feeding of data into the portal on Fund Flow and Foodgrains Management module of the MDM-MIS, a Hands on Training sessions is scheduled to be conducted during 2<sup>nd</sup> fortnight of February, 2013 as per details given at <u>Annexure-I</u>.
