The meeting with all the States/UTs on the subject mentioned above was held on 25.06.2021 at 03.00 p.m. through Video Conferencing under the Chairmanship of Director (MDM) to discuss 'Fortification of Rice & its Distribution under Public Distribution System' and to streamline the above mentioned scheme.

Minutes of the meeting on Centrally Sponsored Pilot Scheme on "Fortification of Rice & its Distribution under Public Distribution System"- under Mid Day Meal Scheme (MDMS) with States and UTs.

The meeting of the centrally sponsored pilot scheme on "Fortification of Rice & its Distribution under Public Distribution System"- under Mid - Day Meal Scheme (MDMS) with States and UTs was held in New Delhi through video conferencing on 25.06.2021. The list of participants in the meeting is enclosed at *Annexure-I*.

The agenda of the meeting was:

- To review the status progress and assess readiness of the States and UTs for provision of fortified rice under MDMs.
- ii. To discuss all the issues pertaining to rice fortification and clearing the qualms if any, for the better coordination for the provision of fortified rice in association of Ministry of Food & PD and FCI.
- 2. Director MDM welcomed the officials from all the States and UTs who have participated in the meeting and made opening remarks. He appreciated the State Government's initiatives already taken for the provision of fortified rice under MDMs. He further mentioned that this Ministry has agreed to bear the revised incremental fortification cost @ 73 paisa per kg for the Pilot Scheme Fortification of Rice and its distribution. He clarified that food grains are already being provided by FCI as of now for MDMS, under this present scheme fortified rice shall be provided to States and UTs in place of normal rice as per the capacity of FCI. The Fortified Rice Kernels contains, Iron, Vitamin B 12 and Folic acid as a fortificant. He invited Shri Sharma, DS Dept. of Food and PD, for comments. Shri Sharma opined that clarity has been made through the initial remarks of director MDM. However, a clarification letter may again be sent to States and UTs if required.
- 3. The representative from FCI mentioned that fortified rice is being made available to almost all the States and UTs. As a progressive data almost 3.36 lakh MTs for fortified rice have been procured and made available to States and UTs. However, lifting of fortified rice is not encouraging and rice is lying in go-downs of Punjab and Chhattisgarh. He further opined that States and UTs may be facing some challenges in lifting of fortified rice and as the lifting is not very prompt. He further opined that States and UTs needs to be clarified how the reimbursement of Rs. 0.73 paisa shall be provided especially to the NER States. Director MDM, informed that letter has already been issued to States and UTs vide letter dated 31st March, 2021. However, a letter may again be sent to States and UTs clarifying that Govt of India will bear the extra expenditure of Rs. 0.73 paisa of cost of fortification. It is further clarified that in case of late payment to FCI Govt. of India has already parked Rs. 300 crores to FCI in case of any pendency in payment.
- 4. On the query raised by SNO MDM Odisha, Director MDM, DoSE&L clarified that, FCI pre-blended ready to use fortified rice will be provided by FCI and therefore State need not carry out the blending activities like they were doing in Gajapati District. In a 50 kg bag 500 gms of FRK shall be added i.e. 49.5 kg with normal rice shall be blended with 500 gm FRK. For IEC activities to publicize that design and posters prototype may be obtained from FCI and FSSAI and for publicity MME funds may be used.

- 5. Replying to, representative from Goa, Director MDM mentioned that State has the liberty to select rice or wheat as per their choice and cultural acceptance, in case of Goa as they are only using wheat as on date they may continue to do so. Director MDM advised States & UTs to carry out discussion with FCI officials at State/UT level and their readiness for provision of fortified rice regarding the coverage of other districts on the query raised by Shri Mumtaz Ahmad, Finance Controller, Uttar Pradesh.
- 6. Shri L. P. Sharma, Deputy Secretary, Department of Food & Public Distribution informed on the query raised by Officials from Jammu & Kashmir that there will be a +F mark on the bag itself so that fortified rice can be differentiated. He also mentioned that the FRK blended rice has the shelf life of approximately one and half years.
- 7. Shri Jeevanbabu, DGE Kerala, mentioned that State has made a request for parboiled rice (fortified) as that is preferred by the children in the State. Initially the parboiled rice was being procured from Andhra Pradesh. However, now the FCI has informed that the raw rice is being procured from Punjab. Director MDM, Govt. of India suggested to discuss the issue with FCI and in order to resolve the issue in coordination. Representative from FCI mentioned that the capacity building for the provision of parboiled rice FRK needs to be built in. The availability of boiled rice is also less which needs to be worked out. Director MDM opined that until the boiled rice FRK is made available state may not me pressurized to utilize raw rice as food choices are culture specific.
- 8. On the query raised by Commissioner MDM Gujarat, Director MDM clarified that for the distribution of first quarter of rice which has been already lifted by State and UTs can be distributed as it is not possible to blend with FRK now, However they may start the distribution of fortified rice as an when FCI provides the same.
- 9. Mr. Ambrose Marak, Meghalaya asked whether that FCI can provide fortified rice in Shilong and Ribhoi districts. He further suggested that FRK rice may be provided at Tura region so that it will be easy for Garo area distribution and for Khasi hill region. FCI representative informed that 227 MTs of fortified stocks have been placed at Ribhoi districts, FCI will be able to provide in Garo, Khasi and Jaintia districts through road as they are already doing for other projects. He further informed thatthey will take up the matter with their regional center and requested the state to place a request to State regional office also for better coordination.
- 10. Director MDM mentioned on the query raised by Shri Shamim Bahadur Lakar from Assam that a letter has already been issued on 31st March 2021 that fortified rice shall be provided in all the districts where FCI is in a position to supply the fortified rice.

11. Following Action Points emerged from the discussion.

- a. D/o SE&L, Ministry of Education shall bear Rs.0.73 cost per kg of rice cost fortification for rice.
- b. States and UTs may conduct meetings with State regional offices regarding the availability of fortified rice.
- c. FCI may take up the matter or provision of parboiled rice FRKs blended in fortified rice for the southern States that have such cultural food preference.
- d. State and UTs may issue necessary instructions to all the stakeholders at district level regarding preparedness on the provision of fortified rice.

- 12. Director MDM informed the States and UTs to implement the new system for release of funds in line with the directions of Department of Expenditure, Ministry of Finance, and Govt. of India.
- 13. Director MDM requested all the States and UTs to share their, best practices, case studies, Photos, videos (HD) quality, initiatives of to be incorporated in the India MDM Report by 30.06.2021.

Meeting ended with a vote of thanks to the chair.
