#### AWP&B 2015-16 Plan Formulation

- The exercise of bottom up approach starting from the school level will be followed by all the Districts and Sub-divisional officers dealing with Mid Day Meal Scheme. Taking stock of the happenings during the year, draw lessons and incorporate them in the District Plan.
- Authenticity and correctness of figures like enrolment, etc. is the main point of concern and special attention will be taken while the plan is being formulated.
- Trainings will be conducted soon for all the Districts/Sub-Divisional Officers and their inspecting staff to acclimatize themselves with the various steps required for the preparation of the AWP&B 2015-16.
- The Districts /Sub-Divisional Officers will be clearly instructed while preparing the District Plans to base all their data by taking into consideration all the records of implementation maintained by the schools.
- UDISE Data is one of the main criteria on which the information for preparation of the Annual Work Plan and Budget for 2015-16 will be based.
