Subject: Submission of proposals for release of 2nd instalment of Recurring Central Assistance under Mid Day Meal Scheme - reg.

Sir / Madam,

I am directed to say that ad-hoc release @ 25% of the recurring admissible central assistance was released in the month of April, 2017 and the balance 35% from the first instalment during July-September, 2017 after adjusting the unspent balance of the previous year reported by the States / UTs to all the States / UTs for the smooth implementation of Mid Day Meal Scheme during 2017-18. Thus, 60% of the funds have been made available to all the States/UTs.

2. The second quarter of the year 2017-18 is already over. By this time, all the States/UTs must have utilized the recurring central assistance released so far under ad-hoc and balance of first instalment. The State/UTs may now submit their proposal for the release of second instalment of recurring central assistance along with following information:-

- i) Component wise expenditure statement as per **Annexure-I**, confirming that State/UT has utilised 60% or more from the available recurring central assistance (unspent balance as on 01.04.2017 and recurring central assistance released during 2017-18 under ad-hoc and balance of first instalment).
- ii) Confirmation that the State has released its minimum mandatory matching share against the recurring central assistance for cooking cost and honorarium to cook-cum-helpers.

3. The proposal for the release of recurring central assistance for second instalment of above said proposals under Mid Day Meal Scheme may be submitted in the prescribed formats to this Ministry **by 30th October, 2017** to enable MHRD for timely release of funds.
